# Technical information about this website's accessibility

## Non-accessible content

Due to certain constraints, we have had to include technologies and features that may cause accessibility issues. These include:

## Non compliance with the accessibility regulations

• **Timing adjustable (2.2.1)** - the email sign-up form currently relies on browser validation fields which do not always persist for users. We hope to have native validation in place by December 2025.

### **Disproportionate burden**

Not applicable at the present time.

### Content that's not within the scope of the accessibility regulations

- The site logo utilises text in an image as an essential part of the NHMF brand and is not currently editable. It currently has an alt text of 'Home' which reflects its other function of linking to the site homepage. The W3C advises that images used as logos are exempt from some of the accessibility requirements that apply to other images of text
- Some older PDFs (that are not vital to the application process and predate
  23 September 2018) are not accessible
- Social media embeds (third-party applications)
- YouTube (third-party video application), including videos generated by partners
- Grant application system (third-party database)

We are making every effort to overcome these limitations by improving their accessibility and failing that, provide accessible alternatives.
